When the city of Houston hosts its first Fleet Week, Nov. 5–12, I am working with our American Legion posts to welcome the hundreds of sailors, Marines, and Coast Guard professionals to Texas.

As a Marine aviator, I participated in three Navy Fleet Week events. I remember these events as a chance to share my military experience with younger people, to encourage them to serve our nation. It was a great opportunity to educate our taxpayers but also to connect with our veteran community.



Fleet Week Houston will mark the first time the U.S. Navy has brought this tradition to Texas, featuring three naval vessels and more than 1,000 sailors, Marines and Coast Guardsmen.

The weeklong lineup includes ship tours, family-oriented activities, educational outreach, community service projects, business forums and lively celebrations. Houston will also host the U.S. Marine Corps' 250th birthday on Nov. 10 and celebrate the Navy's yearlong commemoration of its own 250th anniversary.

The Department of Texas will be working with our districts near Houston to host an info booth Nov. 8–9. We want our Legionnaires to work with our community leaders to welcome these military professionals to the Lone Star State.

To me, the Fleet Week opportunity provides an excellent chance to showcase the American Legion's leadership to our future members and their families. It's also an opportunity for our posts to collaborate with their local high school Junior ROTC units to showcase potential careers in these three branches of military service.

History of "The Legion Times" – Wow, How Things Have Evolved Submitted by Shirley Platt – Department Historian

A serious attempt was made to inaugurate a Department Publication, a newspaper, from the very beginning days of the Legion, in 1919. Initial starts were unsuccessful and publication was suspended. Instead of a newspaper, the Department was obliged to send out bulletins to disseminate official information. For ten years the Department struggled, as reflected in the minutes of the Department Executive Committee and the Department Convention. Many things occurred to upset plans. There were printers' strikes, funds vanished, and editors resigned without warning.

Placed under new management, following the Amarillo Convention in 1926, the newspaper was published irregularly until 1929. At the Convention that year, delegates earmarked twenty-five cents from each member's dues for the "Texas Legion News" and instructed the Department to take charge of the publication. After that the newspaper came out regularly once per month, except in 1946 and 1947 when it was published semi-monthly. At the end of each year, copies of each issue have been bound and placed in the Department Headquarters where they furnish a rich source of Legion information.

Costs for the publication of the Texas Legion News, like other things in an environment of slowly moving inflation, began to rise. Other programs were curtailed sometimes, but somehow the publication of the Department's bi-monthly newspaper was never interrupted. To 1983, the Legion News consisted of 16 pages, eight by eleven inches. From that year, the Texas Legion News accepted the Auxiliary's paper, the Lone Star News, as an "inside" four-page section. The News was printed on a fold of 12 pages, twelve by eighteen inches, yielding a more economical arrangement for both the Department and the Auxiliary. Subscription rates were stabilized at 80 cents per year per member.

- Submit text in Word format (.doc, .docx) or as a text file (.txt or .rtf) or as a PDF. ONE ARTICLE PER EMAIL PLEASE.
- The ideal word count for our format is 200 500 words (maximum), with no double spacing.
- Give your article a TITLE! Create a HEADLINE and save with a proper file name so we can easily recognize it.
- Tell us who the author is, whether it's you or if you are just forwarding it to us.
- Attach any photos or artwork for your article separately in your email. DO NOT embed them in your Word or PDF file. Larger photos are best, and high resolution JPG files of 300 dpi or better are preferred. Please name these files accordingly so we can track them along with your article.

- Let us know in your e-mail or Word doc of any photo captions, the name of the photographer, etc. Please note that due to spacing and layout requirements, we may not be able to use every photo or caption submitted (preferably 2 3 photos per article).
- Please spell check everything! Especially people's names, web addresses, etc. We do our best to catch typos, and make corrections, but sometimes they still slip by. You can help us greatly by simply running the spell check function in your word processing software.
- We publish on our Website on the FIRST FRIDAY of the Month, with few exceptions. E-mail everything directly to times@txlegion.org by the 20th of every month, for it to appear in the following issue. Submissions received after the 20th will be considered, but may be held over or discarded due to space and layout restrictions.

Dale Outland is no stranger to being called to provide emotional and spiritual support to families and Post 178 veterans who have dealt with tragedy. As post chaplain he completes buddy checks with members who are experiencing major health problems, giving them words of comfort.

Chaplain Outland, who is a 14-year U.S. Army infantry veteran, is also a former disaster chaplain volunteer for the Austin Disaster Relief Network. As a disaster chaplain he has assisted in providing services and resources to families affected by hurricanes in South Texas.

After his military service, he served 23 years as a Mississippi police officer and 10 years in the MS State Guard, attaining the rank of Command Sergeant Major. As the result of major hurricanes, he helped provide police security and safety operations for Red Cross shelters.

Additionally, as a disaster chaplain volunteer for the Crisis Response Ministry of Collin County Law Enforcement he recently answered the call to deploy to the Kerrville, Texas flood area. He was contacted in July to assist families and first responder volunteers affected by the recent disastrous flooding of the Guadalupe River. He was assigned to the Camp Mystic site near Hunt, TX. During his weeklong stay, he frequently met and prayed with parents, families, and friends of flood victims, as well as volunteer responders, to provide spiritual and emotional support.

Chaplain Outland shared that it was tremendously sad to see the extent of the devastation and loss of life, but he felt grateful to share the word and strength of God's blessings.

Live Oak County Post 413 - Three Rivers - Visited by Texas Historical Commission

In recognition of the American Legion's 90th birthday (2009), the Senate and House of Representatives passed a resolution designating Sept. 16 as "American Legion Day".

On September 16, 2025, The Texas Tropical Trail Region, which is part of the Texas Historical Commission, hosted its Partner Event. This event started at the Three Rivers City Hall, a walk to the Rialto Theater for a tour, a drive to Choke Canyon State Park for a presentation, lunch at the Live Oak Restaurant, ending at the Live Oak County American Legion Post #413 in Three Rivers, Texas, for a presentation. Post Commander Rosendo Pena, Joe Crawfod - Post Historian, Lenore Hackenyos - Post 380 Commander (representing Tony Lopez, 3rd Division Department Commander), Gea Clausier -14th District Commander and Shirley Platt -Department Historian gave greetings to the audience, the history of the American Legion and the history of Post #413. The post was chartered on December 7, 1946. The building they occupy is over 100 years old.

The Mission of the Texas Tropical Trail Region and its partners identify, is to preserve, interpret, and promote the natural, historic, and cultural resources of South Texas. The Texas Heritage Trails Program (THTP) is the Texas Historical Commission's (THC) award-winning heritage tourism initiative. This economic development initiative encourages communities, heritage regions, and the state to partner and promote Texas' historic and cultural resources. These successful local preservation efforts, combined with statewide marketing of heritage regions as tourism destinations, increase visitation to cultural and historic sites and bring more dollars to Texas communities. This in turn supports the THC's mission to protect and preserve the state's historic and prehistoric resources for the use, education, economic benefit, and enjoyment of present and future generations.



The THTP is based around 10 scenic driving trails created in 1968 by Gov. John Connally and the Texas Highway

Department (now the Texas Department of Transportation) as a marketing tool. The trails were established in conjunction with the HemisFair, an international exposition that commemorated the 250th anniversary of the founding of San Antonio.

In 1997, the State Legislature charged the THC to create a statewide heritage tourism program. The program began with the establishment of the Texas Forts Trail Region in 1998. Other heritage regions made a formal application to the program, demonstrating knowledge of area attractions and broad support from organizations and local government. The suite of heritage regions was completed in 2005 with the additions of the Texas Pecos and Hill Country Trail Regions.

POW/MIA Sunset Vigil Carries On Despite Storms

On September 21st, Holley-Riddle Post 21 of The Colony, TX prepared to host its 4th annual POW/MIA Sunset Vigil at Stewart Creek Park on the banks of Lake Lewisville. It began as a beautiful day, slightly cloudy, which managed to keep the temperature at 90 degrees as Post and Squadron 21 members arranged chairs, bleachers, flags, canopies, and sound equipment while musicians unpacked their instruments.

But this is Texas, where weather can change in an instant. Within minutes, thunderstorm watches were issued, sirens sounded, and lightning appeared on the horizon. Though skies above the lakeside site remained clear, dark clouds circled the park.

"We were watching the weather intently and receiving reports from The Colony Fire Department," said Commander Mary Garcia. "Safety was the top priority. But we also wanted our young performers and guest speaker to share their message. After so much practice and preparation, we didn't want to cancel the ceremony."

As conditions worsened, Commander Garcia's military training kicked in. She conferred with city officials and proposed a solution to find an indoor venue. The City Annex, a large meeting room belonging to The Colony, just happened to be vacant that night. Commander Garcia made the decision to move the event indoors.

That is when the miracle started... Community came together - Scouts, performers, parents, Legionnaires, guests - everyone immediately pitched in and began loading up dozens of chairs, tables, canopies, gathering up all the equipment, completing the task in less than 15 minutes. Local attendees helped visitors find the new location, even riding with them to ensure they got to the site.

Once indoors, Scout Troop 226 opened the ceremony with the Pledge of Allegiance. Richard Boyer, mayor of The Colony, emphasized the city's respect and support for the sacrifices made by veterans and their families, and thanked Post 21 for continuing to bring meaningful military observances to the community.

The vigil featured a moving POW/MIA table observance, staged as a family setting the dinner table while waiting for word of their missing loved one. Each item placed on the table was explained, symbolizing the sorrow of families still awaiting answers. A poignant moment came when Patricia Zuczek reported that the remains of Navy Petty Officer 3rd Class Storekeeper Robert Stillman Garcia, a south Texas sailor, were positively identified through DNA testing by the DPAA. After 80 years, SK3 Garcia is finally coming home to be laid to rest in the Coastal Bend State Veterans Cemetery.

The keynote speaker, Chaplain Nathan Tucker, LTC, US Air Force, delivered an uplifting message of comfort and hope, ensuring everyone that our POWs and MIAs are never alone as long as we hold them in our hearts. Noting the participation of Scouts and youth performers, he reassured listeners that new generations are returning to faith and American values. Chaplain Tucker told of presiding over the military funeral of a recovered MIA soldier at DFW National Cemetery. "I didn't need to give a sermon that day," he said, "You could see it in the eyes of the family who finally can lay their loved one to rest." He referred to Psalm 121, which symbolizes God's unwavering protection, guidance, and faithful care for His people.

The audience was treated to a beautiful collaboration of strings and flute, as a special youth group from a local congregation of the Church of Jesus Christ of Latter-Day Saints performed "God Be With You 'Til We Meet Again." Pianist Grigoriy Gazaryan played a moving nocturne by Chopin. Alex Purser brought tears to the eyes of many with his singing of "You Raise Me Up" and "Homeward Bound."

The ceremony concluded with the playing of TAPS, and everyone holding up LED candles, vowing to share the light of hope and never forget. Though storms forced a last-minute change of venue, the vigil remained a powerful tribute—proving that with determination and community spirit, the mission to honor and remember POWs and MIAs will always carry on.

San Saba Celebrates Legacy: American Legion Post 27 Dedicates Texas Historical Marker

San Saba, Texas – September 11, 2025 – On a crisp morning marking the 24th anniversary of the 9/11 attacks, the American Legion Wiley B. Murray Post No. 27 unveiled a new Texas Historical Subject Marker at City National Bank, honoring over a century of service to veterans and the community. The dedication ceremony drew 43 attendees, including Legionnaires from neighboring posts in Goldthwaite, San Angelo, Llano, and Brownwood, as well as Texas Department Commander Richard Huntley, highlighting the ceremonies.

Held at 209 East Brown Street, the event began at 10:00 a.m. with Jerry Blankenship, representing the San Saba County Historical Commission, serving as Master of Ceremonies. C.K. Stevenson, First Vice Commander of Post 27, delivered an opening prayer. Post Commander Jan K. Huffstetler then led the pledges to the U.S. and Texas flags. County Judge Jody Fauley offered warm welcome remarks, emphasizing the marker's role in preserving local history. Department Commander Richard Huntley followed with insights into the origins of the American Legion, founded in 1919 to support World War I veterans. Don Gray, 21st District Commander, spoke on the Legion's vital contributions to communities, from youth programs to veteran advocacy. Sam Murray, President of City National Bank, shared personal remarks on behalf of the bank and the Murray family, whose legacy is intertwined with the post's history.

The highlight came as Huffstetler and Huntley unveiled the 27-by-42-inch marker, while Past District Commander Jeff Meurer read its inscription aloud. The plaque details the post's founding in 1919, shortly after World War I, when San Saba veterans were aided by the local United Confederate Veterans Camp No. 322. Named after Wiley B. Murray, son of bank president T.A. Murray, who died in France in 1918, the post received its charter on August 13, 1919—making it one of Texas's earliest. Early efforts included escorting repatriated remains of local fallen soldiers, forming a women's auxiliary in 1921, and community projects like Christmas gifts for children, patriotic school programs, and developing Mill Pond Park.

During World War II, members supported the war effort and later assisted returning veterans with G.I. Bill benefits. In 1946, the San Saba Vocational School for Veterans was established, with Legionnaires Ray W. Harris, Warden Terry, and T.A. Davenport teaching classes. The post's 1959 meeting hall became a community hub, embodying the Legion's pillars of service.

This marker is the sixth known Texas Historical Commission (THC) recognition for an American Legion post in the state, joining esteemed sites like Donna Border Post No. 107 (the world's first Legion-owned hall, marked in 1964), Hurst-Euless-Bedford Post No. 379 (2022), Hanson Post No. 54 in Amarillo (2011), Parramore Post No. 57 in Abilene (1998), and Hudgeons Post No. 230 in Hallettsville (2015). The THC's selective program honors posts with significant historical impact, and Post 27's century of dedication qualified it for this distinction.

Blankenship provided closing remarks on behalf of the Historical Commission, followed by Stevenson's benediction. Attendees then posed for photos at the marker and a group shot, capturing the camaraderie. Commander Huntley then presented Commander Huffstetler a check for \$10,000 to assist victims of the recent flood in San Saba. Participants then headed to a local restaurant for lunch and a roundtable with Commander Huntley.

Post Adjutant emphasized the event's significance: "This marker ensures our story inspires future generations." The dedication not only commemorated Post 27's past but reaffirmed its commitment to San Saba, where veterans continue to build community strength. As one attendee noted, "It's about remembering those who served—and serving those who remember."

That evening, the post hosted its quarterly meeting at the hall, starting at 5:30 p.m., with barbecue and pinto beans served at 6:30 p.m., complemented by member-brought sides. The gathering featured Boys & Girls State students from San Saba High School and welcomed all veterans, families, and supporters.
